The New Shares rank pari passu in all respect with the existing shares of the Company. The New Shares are expected to be listed and quoted on Catalist of the Singapore Exchange Securities Trading Limited with effect from 9.00 a.m., Thursday, 27 July 2017.

Following the allotment and issuance of the New Shares pursuant to Warrants exercise, the total number of issued shares of the Company has increased from 8,783,665,628 to 8,869,361,028.

The Company will make periodic announcements on the utilisation of the Exercise Proceeds as and when such proceeds are materially disbursed.
